Methods of payment

By Direct Debit from a U.K. registered Bank account. Please note that the preferred method of payment is by Direct Debit. We may hold any of the following items of personal information about you:

- Employee details.

- Details of your attendance at ICE events.
- Professional interests.
- Membership of professional committees.
- Details of knowledge products or services purchased from TTL.
- Details of voluntary donations made to the ICE Benevolent Fund, QUEST and/or the R&D fund.

The Institution of Civil Engineers and Thomas Telford Ltd maintain data on all members. We also maintain data on non-members who use our services.
